DISTRICT PRECAUTIONS

- Plexiglass installed in offices and points of sale
- UV-C light source sanitizing devices
- Additional air filtration
- Additional custodial staff
- Staff training
- Staff and students encouraged to bring hand sanitizer
- Increased inventory of hand sanitizer, sanitizing stations
- Build in hand-washing to daily routines and time for hand sanitizer
- Water bottle filling stations
- Daily screener as part of student registration

MASKS AND FACE COVERINGS

Parents, students, and staff will make their own informed choice regarding the use of masks or face coverings in school facilities and at school activities.

- *Current public health agency guidance recommends use of masks or face coverings in school.*

Use of masks and face coverings are not prohibited during the six-month time frame of this Board approved plan.

Masks and face coverings must adhere to all dress code requirements outlined in student and staff handbooks and board policy.

TRANSPORTATION

- The Directive from the Indiana State Department of Health and the Indiana Department of Education Director of Transportation requires everyone to wear face coverings while using public transportation, including school buses.
- Seating charts will continue to be utilized in order to assist in contact tracing of positive COVID-19 cases.
- Disinfectant spray will be utilized in bus Interiors on a weekly basis, weather permitting. More frequent cleaning may be required on a case by case basis.

PARENT VOLUNTEERS AND VISITORS

- We will begin the 2021-22 school year without parent volunteers and visitors during the school day.
- This practice will be evaluated, at minimum each nine week period.

OUTSIDE PRESENTERS, TUTORS, AND INSTRUCTORS

- Outside presenters, tutors and instructors will be allowed on a case by case basis with proof of full COVID-19 vaccination.

BACK TO SCHOOL EVENTS

- Back to School Events will be allowed.
- Social distancing will be facilitated as well as modifications of food preparation and distribution during the events.

FOOD SERVICE

- LCSC contracts management of Food Service to Aramark Corporation.
- Current Aramark policy states that vaccinated workers are not required to wear masks.
- Our Food Service employees (other than the Aramark employed manager and select personnel) are LCSC employees.
- Because of uncertainty and inability to require vaccinations or verify vaccination status, we will require masks for all Food Service Employees until further notice.

RECESS

- Recess in elementary schools will return to pre-COVID-19 schedules.
- Activities that would involve students in groups in close proximity for extended periods such as the Gaga Ball Pit will not be allowed at this time.

ATHLETICS

- Full spectator capacity at athletic events
- Social Distancing Encouraged (especially indoor events)
- Social Distancing stickers will remain on bleachers to encourage Social Distancing
- Face Coverings will be strongly encouraged for unvaccinated individuals
- Signage and announcements to encourage both Face Covering and Social Distancing
- Protocols could change depending on community spread

COMMUNICATION OF POSITIVE CASES

- LCSC will continue to report cases to the Indiana State Department of Health as requested or required.
- LCSC will continue to maintain our data dashboard indicating the weekly number of positive cases within the Corporation.
- LCSC will discontinue the practice of communicating positive cases in real time to staff and students through our mass communication resources.

COLLABORATION WITH LOCAL AND STATE HEALTH OFFICIALS

Lebanon Community School Corporation will continue to collaborate with local and state health officials and follow guidelines from the Centers for Disease Control in order to maintain adherence to best practices in the following:

- Contact tracing
- Isolation and quarantine for exposures
- Face masks
- Athletic participation and spectator requirements
- Sanitation requirements
- Transportation requirements
- Recess requirements
- Visitors and volunteers
- Vaccination opportunities
